

**DECREE**  
**PREIDENT of the REPUBLIC of TAJIKISTAN**

**“On Reorganization of Agricultural Enterprises and Organizations”**

With the aim of improvement of economic reforms in the republic I hereby resolve:

1. Prior to December 31, 2001 to provide reorganization of 120 agricultural enterprises and organizations pursuant to Resolution “On Reorganization of Agricultural Enterprises and Organizations, approved by Decree of the President of the Republic of Tajikistan No.522 as of June 25, 1996.
2. To create State commission on reorganization of agricultural enterprises and organizations in accordance with Appendix 1.
3. That Chairmen of oblasts, cities and rayons should form the appropriate commissions on reorganization of agricultural enterprises and organizations in accordance with Appendix
4. To create an information-analytical department in the central office of the Committee for Land Resources and Land Management under the Government of the Republic of Tajikistan With the aim of operative preparation of information about quantity and quality of lands and registration of dekhkan farms.
5. That the Government of the Republic of Tajikistan should undertake necessary measures resulting from the present Decree.
